WHAT IS "ARMENQA"?

TEMPUS "ARMENQA" is a three-year project of national importance leading to the implementation of National and Sectorial Qualifications Frameworks (NQF and SQFs) in the Republic of Armenia. The Project is financed by the European Commission in the framework of the European Neighbourhood Policy.

The project aims at enhancing the employability of Armenian Higher Education Institutions' graduates and facilitating recognition of the Armenian qualifications in labour market both at national and international levels.

The project has adopted holistic approach to the implementation of the NQF and SQFs with the specific objectives of:

- Operationalisation of the National Qualifications Framework of Armenia (NQFA) by creating and utilizing a set of legislative, regulatory and methodological bases and tools,
- Capacity building of main stakeholders such as Higher Education Institutions, students and graduates, employers and labour market representatives, state regulatory bodies and social partners on the NQFA,
- Development of the national model and methodological basis for the establishment and piloting of SQFs in Armenia,
- Provision of reference points, methodological basis and practical tools to the Armenian Higher Education Institutions for the development of learning outcomes (LOs) based multilevel study programmes coherent with the NQFA, SQFs and relevant to the demands of labour market.



WHY IS NATIONAL QUALIFICATIONS FRAMEWORK

OF ARMENIA IMPORTANT?

The NQFA comprises all the qualifications provided by the Armenian educational institutions at all levels. It is a comprehensive tool that describes what the graduate has achieved in terms of knowledge, skills and competencies at the particular level of qualification and supports the transparency, comparability and recognition of the qualifications issued in Armenia. The primary beneficiaries of the NQFA are the Armenian Higher Education Institutions, labour market, state regulatory bodies, students and the society at large. The implementation of the NQFA will facilitate the employability enhancement of the graduates by providing employers an interpretative tool to comprehend the qualification within the job requirements imposed by labour market, meanwhile being assured of the recognition and the level of a particular qualification. The NQFA will facilitate the mobility of students and graduates at the international level and will foster the recognition of the qualifications abroad.

WHO ARE BENEFICIARIES AND WHAT DO THEY BENEFIT?

► Higher Education Institutions:

- Provision of reference points for development and evaluation of the degree programmes in terms of LOs,
- Interpretative tool for the recognition of the qualifications received abroad and vice versa,
- Accountability of Higher Education Institutions on the qualifications awarded.

► Employers:

- Facilitation in respect of understanding the qualifications within the job requirements imposed by the organisation or labour market,
- Provision of information on the knowledge, skills and competences obtained at the particular level of qualification.

► Society including students and graduates:

- Mobility facilitation at national and international levels,
- Employability enhancement,
- Fostering individual development by validation of informal learning.
