
- Supporting the definition of internal quality standards and determinants in accordance with RA MESCS and other international requirements adopted in RA.
- Support to the implementation of quality assurance processes in all subdivisions of the University.
- Quality control of the elaboration and implementation of educational programmes, curricula and ensuring their compliance with the established standards and requirements and orders of RA MESCS.
- Coordination of self-assessment of the quality of the University's educational programmes and supporting their external assessment and accreditation processes.
- Supporting the University's institutional accreditation self-assessment process, preparing the relevant report and coordinating follow-up actions.



- Quality control of the elaboration and implementation of educational programmes and curricula and ensuring their correspondence to the established standards and requirements and orders of RA MESCS.
- Organization of professional and general trainings for the Faculty and promotion of participation in them.
- Supporting the work of the student scientific society and contributing to the increase in their efficiency.
- Organisation and holding of consultations and seminars on the management, assurance and assessment of the education quality.
- Discussion of resolutions related to the education quality system and quality organisation issues with relevant structural subdivisions and the Scientific Council.
- Support to the implementation of quality assurance processes in all subdivisions of the University.
- Ensuring the transparency of quality management and assurance processes and procedures and the interactive participation of external and internal stakeholders of the University in them.
- Development of standards for assessment of educational quality, procedures and standards based on research.

- Supporting the organisation of the periodic review of educational programmes and the elaboration of new educational programmes in accordance with quality management and assurance procedures, checking the documentation packages of new and revised educational programmes.
- Elaboration of the methodology for monitoring the quality of education.
- Conducting sociological surveys in terms of satisfaction with the education received by graduates and the quality of preparedness with relevant structural units, as well as presenting the results of the surveys to the Rector of the University.
- Conducting research and raising issues aimed at increasing the efficiency and quality of educational and other processes in the University.
